### WARREN COUNTY CARES ACT GRANT PROGRAM



The County Commissioners used \$2,145,000 of CARES Act funding to create The Warren County CARES Act Grant Program. The Board designated three focus groups: Small businesses, non profits, and childcare centers, and partnered with the Warren County Small Business Alliance to be its program administrator. Additionally, \$25,000 was set aside for volunteer-based non-profits. These grants will be awarded at the Board's discretion.

### "MASK MONDAYS"




During the month of October, KN95 masks were distributed at local fire departments to those who identify as more at-risk members of our community.

### ADDITIONAL FUNDING FOR CDBG PROJECTS



### 1 SUPPORTING SENIORS THROUGH COVID DRIVE

### WARREN COUNTY RECORDS

Technological advancements made by Warren County over the past decade have allowed us to weather the pandemic with minimal issues. One example of this is the digitization of our records. Warren County Recorder, Linda Oda has worked with her team to prioritize getting all books recorded online. ### 4 WARREN COUNTY SCHOLARSHIP UPDATE





Through our contributions from 2007 until now, scholarship funds have reached **\$590,041** and **5,727** students have been impacted.

### **5** PROJECT TRITECH LAUNCH

On September 1, 2020 Warren County's Telecommunications Department executed a seamless transition to its new Computer-Aided Dispatch/Records Management System/Jail Management System Suite, known as Project TriTech. The new system is customized to how our County's emergency response agencies function, and after 17 years has replaced the former Premier CAD program. The Project Implementation Team spent months training first responders, dispatch, and support staff on all of the system's functions. Everything done in preparation to Go-Live, ensuring that there would be no interruptions in providing Emergency Management's round-the-clock services to the community.
