CHILDREN SERVICES SCHOOL SUPPLIES DRIVE

Warren County Children Services is in the middle of their annual school supplies drive. Each year 700 backpacks are packed and distributed to children throughout Warren County. Not only do the backpacks go to students for the new school year, but can be utilized as children come into foster care at any time. Project lead, Misty Treadway ensures that no donations are turned away and says the biggest need is for high school and kindergarten backpacks. Misty

and her team also help provide supplies to children in juvenile detention and Mary Haven. The success of the program year after year is made possible through the generosity from our community and the efforts of the children service's team.

DEBT SERVICE PAYOFF

RADIO UPGRADES

All communication services for police, fire and state agencies within Warren County occur via radio frequency. In 2013, Warren County Telecom began needed system upgrades. By connecting to the State's Multi Agency Radio Communication System (MARCS) the county was able to save \$1 million, making the borrow for this project, \$8.3 million, scheduled to be paid out at the end of this year. In addition to decreasing the project cost, the collaboration with MARCS enables Warren County radios to roam anywhere in Ohio, making for an even more robust build out.

HOSTING CONGRESSMAN CHABOT'S STAFF

Several projects taking place throughout the county were shared with Congressman Chabot's staff during their recent visit. The group received a debriefing and front row view of our county's major road improvements such as the planned widening of State Route 63 and the King Avenue Bridge Replacement over the Little Miami State and National Scenic River.

SPUR FROM TELECOM

SERVICE + PRODUCT UTILIZATION REPORT

Warren County Telecommunications released the Service + Product Utilization Report (SPUR) for 2021. SPUR provides an overview of the quantifiable Telecom products & services utilized by all cities, villages, and townships in Warren County. This report gives a picture of where the Board of County Commissioners is investing resources in public safety services and technology on behalf of all communities within Warren County.

SPUR encompasses the total value of current products and services utilized within our communities. Including, radios, fire pagers, HipLink mobile messaging licenses, mobile data computers, records management systems, and more!

ORGANIZING AROUND ONEOHIO

A STATE & LOCAL RESPONSE TO THE OPIOID EPIDEMIC

In March, Commissioner Shannon Jones convened over 30 appointed and elected officials and various stakeholders to discuss the OneOhio MOU, an outcome of Ohio's ongoing opioid litigation. Communities throughout the state are working to stand up a governing structure that meets the needs of their region. Sitting in region 14, Warren County has organized a local governance board that will take the lead on prioritizing local projects that will filter up to the state foundation board.



A DEEPER LOOK AT THE ONEOHIO MOU

The OneOhio MOU is an \$808 million settlement agreement between the State of Ohio, in collaboration with many of its local governments, and the three largest distributors of opioids. As a one-of-a-kind approach, the MOU puts an emphasis on all local governments in the state, ensuring that their voices are heard. The MOU facilitates a structure that enables directly impacted communities to build out solutions that match their local needs.


